

The Privacy Policy for the "Yitzhak Rabin Israel Research Center" Website

The Yitzhak Rabin Israel Research Center ("the Center") welcomes visitors to its website ("the Website"). Herein is a detailed listing of the terms and conditions relating to the privacy policy practiced on our website and how we collect and utilize the information collected and conveyed to us by the website visitors during the performance of actions on the website:

1. General

- 1.1. Browsing the website is subject, inter-alia, to the terms stipulated in Privacy Policy. Please read the policy carefully since the browsing and execution of actions indicate your consent to that included in the Terms and Conditions of this Privacy Policy.
- 1.2. This Privacy Policy constitutes an inseparable part of the website's Terms and Conditions of Use. Any expression appearing in this Privacy Policy shall have an identical interpretation to that defined in the said Terms and Conditions of Use.
- 1.3. That mentioned in this Privacy Policy relates equally to the two genders. Using the masculine form is solely for convenience.
- 1.4. The Center reserves the right to update this Privacy Policy at its discretion, and subject to the provisions of the Privacy Protection Law, 5741-1981, as shall be updated from time to time ("the Privacy Law") and without any need for conveying any notification whatsoever. The validity of the said change from its publication on the website.

2. The Information Collected On The Website

- 2.1. When joining the distribution list of the Center (including when reserving tickets), you shall be required to convey personal information, including but not solely your full name, telephone number, date of birth, residential address, email address, and billing details (insofar as relevant.) Those fields for which it is compulsory to fill in shall be marked explicitly.
- 2.2. In addition to the information you convey upon your registration to the website, the Center gathers information about your computer through which you visit and carry out actions on the website. The information is collected automatically (including via "Cookies"). It may include IP addresses, browser type, website entrance and browsing times, the means of browsing and the instrument you are using for browsing purposes, details concerning your internet service provider (ISP), and website addresses from where you arrived. (The information conveyed during the registration process and collected by the Center as stated in this paragraph shall be known together as "The Information Collected On The Website.")
- 2.3. The information collected on the website shall serve the Center, inter-alia, for the website's optimal operation, to preserve a high level of service and quality, and for general statistics regarding the use of the website.

3. The Use Of The Information Collected On The Website

- The Center and/or on its behalf are entitled to use the information collected on the website for the following purposes:
 - To supply you with the information you requested or additional information that the Center believes is of interest to you from time to time;
 - To adapt the Center's advertisements per your personal preferences;
 - So that a representative of the Center may contact you regarding services that the Center provides;
- 3.2. The Center and/or on its behalf shall not disclose and/or sell any information collected on the website to any third party except for those on their behalf to whom they provide the information collected on the site solely to provide a service and who are also obligated to fully protect the confidentiality of the information collected on the website.
- 3.3. Nevertheless, the Center and/or on its behalf shall be entitled to convey information collected on the website to third parties in one of the following instances:
 - You have given your prior written consent;
 - The Center or on its behalf is obligated by law to convey the said information, for example, under a court order;
 - For the protection of the Center's legal and intellectual property rights and/or on its behalf regarding this website.
 - Following any violation of the Terms and Conditions of Use of this website or if performed via the website, or in any connection with the website, actions contradictory to or perceived as illegal, or any attempt to perform such actions.
 - In any instance, the Center believes that conveying the collected information is necessary to prevent severe damage to the user's body or property or to the body or property of a third party.

Furthermore, the Center may convey to third parties solely general statistical information that is not personal or private regarding use on the website, such as the total number of visitors on the website and on each ISP) of the website's visitors.

4. Protection and Security of the Information Collected on the Website

- 4.1. The Center retains all the information collected on the website in an electronic database and takes many strict measures to secure this information. The website's information security systems are constantly under improvement based upon the new emerging threats; however, they are not completely secure. The Center does not guarantee that the information collected on the website shall be completely protected against hacking. Furthermore, it is not within the capability of the Center and/or on its behalf to secure information conveyed to it by a user via email, at least until the arrival of the said email to the Center's website, since it is not subject to the same defensive measures installed on the website.
- 4.2. Moreover, the Center takes measures to explain to its employees the importance of preserving the privacy of the users and the personal information placed in the Center's hands.
- 4.3. It is significant to remember that it is impossible to guarantee 100% against any hostile and determined activity on the part of foreign entities. Therefore, there is no absolute security in these operations, and the Center does not guarantee the website's services shall be absolutely and utterly immune from hacking its collected information.

5. Database Registration and the Right to Peruse the Information

- 5.1. To the extent required by the Privacy Law, the Center shall register and establish a database with the Database Registrar ("**the Database**") and lawfully appoint an administrator.
- 5.2. Under the Privacy Law, every person is entitled to peruse the information about him or held in the database. In information about him that he found to be incorrect, complete, clear or current, he may contact the database owner with a request to correct the information or delete it. In addition, if the information in the database is used for personally contacting the user, the user is entitled, according to the Privacy Law and as stated in the website's Terms and Conditions of Use, to demand in writing that the information relating to him be deleted from the database.
